3. **Membership Dues and Obligations.** I hereby obligate myself for the payment of all dues, charges, and any other fees associated with membership I have applied and have been accepted to.

I understand the Introductory Dues Rates are available to new members through December of their first year of membership only (2012). Following the introductory period, regular dues rates apply as they are established for ensuing years. Members joining under the Introductory Program are not assessable through December of their first year of membership (2012).

4. **Payment of Membership Obligations.** Club accounts are due on the 20<sup>th</sup> of each month. Late fees will be assessed on unpaid balances on the 21<sup>st</sup> of each month. For your convenience, payment of your Club bill can be made from your checking/savings account automatically on the 20<sup>th</sup> of every month via electronic transfer. Completion of a direct debit authorization form is required to use this service.
